### **Employment Opportunities Available:**

- **Behavioral Specialist Consultant (BSC)**

Master's degree or higher in clinical, developmental or counseling psychology, special education, social work, speech therapy, occupational therapy, professional counseling, behavioral analysis, nursing or another related field. . The degree must include 12 credits of core behavioral health coursework. Two years of verified post-Master's experience providing behavior health treatment (one of which is experience using behavior analysis/modification) is required. Licensed and non-licensed

- **Mobile Therapist (MT)**

Master's in a clinical mental health discipline, such as psychology, counseling, clinical social work, psychiatric nursing, and marriage and family therapy. One year paid post-Master's experience providing psychotherapy/counseling to children and/or adolescents is required.

- **Out-Patient Therapist**

Master's in a clinical mental health discipline, such as psychology, counseling, clinical social work, psychiatric nursing, and marriage and family therapy. The degree must include 12 credits of core behavioral health coursework.

- **Therapeutic Support Staff (TSS)**

Bachelor's degree in one (1) of the following disciplines: Psychology, Social Work, Sociology, Education, Criminal Justice, or other Human Service field. If one of the above degrees is held, no work experience is required.

**OR**

Bachelor's degree in another related field with one year verified full time paid working experience with direct care to children and/or adolescents.

**OR**

Associate's degree or 60 Credits toward a bachelor's degree or a Licensed Practical Nurse with three (3) years verified full-time paid work experience working in direct contact with children/adolescents is required

- **Youth Care Worker**

High School diploma, valid driver's license, clear driving record with the ability to be insured by agency insurance company
